 If there is no Fast Start Training class within 50 miles of your home within your first 45 days, you may request to take the virtual class. This option is also available for associates who meet certain criteria (such as a medical condition) for not being able to attend a live class. Other associates must attend a live class. • Recruiting associate must have a previous month-end personal or organizational Performance Club retention rate of 77% or higher to receive full matching bonus. A Performance Club retention rate of 65-76.99% will pay 75% of bonus amounts stated. • Associates are not required to Fast Start qualify to earn the Manager bonus; either or both bonuses may be earned.

• All bonuses will be held for seven business days once earned to verify that all banking information is correct.

• Bonuses will be paid via commission adjustment and will be impacted by any advance recovery.

• The matching bonus is paid to the recruiting associate, which is defined as the placing associate, if applicable, or immediate sponsor if not placed.

• Associates that advance to Manager but do not attend a Fast Start training class within their first 45 days will not be eligible to earn a \$500 bonus or the \$500 matching bonus to the recruiting associate.

• Fast Start to Manager requires 3 Associate legs + \$400 organizational premium or \$400 personal premium.

• Premium for Fast Start Manager qualification bonus cannot include pre-paid credit cards or 6-month direct bill payments.

• Prepaid cards are no longer accepted as a form of payment as of January 1, 2020.
