All Licensed Private Investigators are licensed in the state of Oklahoma. A \$25,000 protection policy (with 1B coverage) or \$1 million protection policy (with 3B coverage) is issued through a nationally recognized carrier. LegalShield/IDShield is not an insurance carrier. Certain limitations apply. Dependent children of the named member or named member's spouse under the age of 23 who permanently live in the same residence as the named member at the time of the stolen identity event are eligible for the protection policy coverage.
