

New Jersey Licensing Information

Requirements

Note: Any applications, fees, or license held in office over 30 days will be returned and/or refunded.

Residents

Residents that currently hold a Property and Casualty license or a Life and Health license in New Jersey, will need to submit a copy of the license and the \$80 appointment fee to the LegalShield Licensing Department.

- To obtain a Legal Insurance license you must apply online at <u>www.nipr.com</u> to complete the license application. You will need to use credit card to pay the \$100 licensing fee.
- Within 5-7 days after applying, your license will be available for printing from the State Based Systems website at www.statebasedsystems.com.
- You will need to submit a copy of your license along with \$80 to complete your company appointment and forward to:

Expiration

The New Jersey license expires biennially on your birth month. The New Jersey appointment expires annually on May 1st, however, if appointments are not renewed on time they will be terminated prior to May 1st, based on the specifics mandated by the state. You will be notified of the renewal.

Non-Residents

Canadian Residents are not eligible to apply for the New Jersey license.

Living in license required states: If you live in a state which requires a Legal Expense license, you are required to hold that license before applying for the New Jersey Producer Legal license. Then, apply for the New Jersey Producer Legal License following the steps listed above.

Living in non-license required states: If you live in a state which does not require a license, you will need to hold a Resident Producer Casualty license in your home state before applying for the New Jersey Producer Casualty license.

- To obtain a license you must apply online <u>www.nipr.com</u> to complete the license application, use credit card to pay the \$115.00 licensing fee.
 - a. The license type is Producer Casualty.
 - b. The license will be issued within 5-7 business days.

 - a. You will need to submit a copy of your license along with \$80 to complete your company appointment and forward to:
