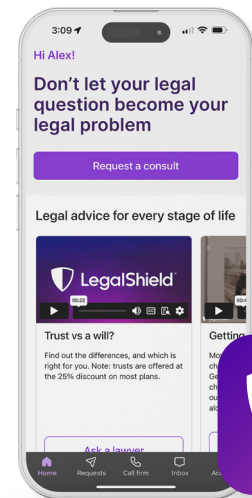
Participants receive direct access to an assigned provider law firm, including 24/7 emergency legal access for covered matters.

ADVICE AND CONSULTATION

- Phone consultations for a wide range of personal legal matters concerning Family, Home, Financial, and Auto Law, Estate Planning, and more.

CIVIL TRIAL DEFENSE*

- Members receive a scheduled number of hours for representation as a respondent/defendant in a covered civil action.

MOTOR VEHICLE*

- **Driver's License Reinstatement**
Legal assistance with any appeal available pursuant to applicable law when the Covered Person has been denied a driver's license or their license has been canceled, suspended, or revoked. (Limited to 2.5 hours of provider law firm time per occurrence.)
- **Moving Traffic Violations**
Each Covered Person will receive defense of two moving traffic violations per Membership Year. (Each time the provider lawyer makes a court appearance, a fee of \$79 applies.)
- **Motor Vehicle Property Damage**
Assistance up to 2.5 hours per claim. The Provider Law Firm can provide a Covered Person with assistance up to, but not including, the filing of or representation in any lawsuit to collect all property damage claims of \$5,000 or less.

IRS AUDIT ASSISTANCE*

- Provides legal advice, consultation, negotiations, and representation if audited by the IRS on a personal income tax return.

FAMILY MATTERS**

- **Uncontested Name Change**
Assistance for an uncontested name change.
- **Uncontested Adoption**
Assistance for uncontested adoption of a minor child.
- **Uncontested Separation or Annulment**
Assistance for uncontested legal separation or uncontested civil annulment.
- **Uncontested Divorce**
Assistance and representation for an uncontested divorce.

Who is covered?

- Member
- Member's Spouse or Domestic Partner
- Dependents of the Member or Member's Spouse up to age 26
- Children under 18 years of age for whom the Member, or the Member's Spouse, is the legal guardian.
- Any Dependent, regardless of age, who is physically disabled or mentally incapacitated resulting in an inability to make legally binding decisions and is
 - unable to be employed
 - 51% or more financially dependent upon the Member or Member's Spouse
 - lives at home with the Member or Member's Spouse
